Upon discussing the issues in the agenda, AMA decided as follows:

- 1. To approve the regulation "On requirements for provision of protected services". (Decision No. 68, dated 20.04.2018)
- 2. To approve a change to AMA Decision No. 1, dated 27.01.2016 "On approving the Audiovisual Media Authority Regulation and Organizational Structure" (**Decision No. 69, dated 20.04.2018**)
- **3.** To renew the "Tok Media" sh.p.k Company license related to the private local audio subject 'In Radio 105.7' (**Decision No. 70, dated 20.04.2018**)
- **4.** To reject the request submitted by the "Albania Studio" sh.p.k Company to review AMA Decision No. 45, dated 19.03.2018 "On rejecting the renewal of the "Albania FM" sh.p.k Company license related to the private local audio "Radio Albanian FM" subject. (**Decision No. 71, dated 20.04.2018**)
